1 PLEASE NOTE

Approval of a Tunisia Business Visa involves the Tunisian Embassy in London seeking prior approval from the Ministry of Interior in Tunisia. As such, processing time on average takes 6-8 weeks. It is highly recommended that you apply for your visa 3 months prior to your proposed date of travel.

Once The Travel Visa Company have completed the online registration of your application, we will require the applicant's original signature on the completed forms. As such, we will need to send the completed forms to you to sign and return to us. Further instructions on this process will be provided at the relevant time.

1. Checklist of the documents required

	TUNISIA BUSINESS VISA APPLICATION FORM – Please find attached. It is important to carefully read through all the questions and fully complete all forms in BLOCK CAPITALS with a BLACK PEN . All application forms MUST be printed single-sided. Application forms printed double-sided WILL NOT be accepted.
	PASSPORT – Please include your original passport. Your passport must be valid for at least 6 months from your date of entry into Tunisia.
	PHOTOGRAPH – The photograph must passport size, taken within the last 6 months, against a light background, printed on photographic paper, be full face and non-smiling [without sunglasses, a hat/cap or other head covering, unless the applicant wears such items because of their religious belief or ethnic background].
	BUSINESS INVITATION LETTER – Please provide a business invitation letter issued by your inviting company in Tunisia. The invitation letter should include the applicant's name and passport number, company address, purpose of trip and date of travel. The letter must be on company headed paper, signed and address to the Tunisian Embassy in London.





UK IMMIGRATION SHARE CODE – If you are a non-UK national residing in the UK, you must provide your UK immigration share code on the application form. This can be obtained at: www.gov.uk/view-prove-immigration-status
HOTEL BOOKING CONFIRMATION - Please include a copy of your hotel booking confirmation. This document must show the applicant's name, hotel name/address and check-in/out dates.
 NOTARISED LETTER OF INVITATION - If you're being invited to Tunisia by family or friends, please include a notarised letter of invitation and a copy of their passport.
RELATVIE'S ID – If you have relatives in Tunisia, please provide copies of their passports.
TRAVELLING COMPANION'S ID – If you're travelling to Tunisia with any individual(s) who holds a British passport, please provide a copy of their passport(s). Doing so can potentially expedite the application.
Pailure to provide us with these documents will result in delays with your application.
