Australia Subclass 600 Application Pack

Thank you for requesting an application pack for an Australia Subclass 600 Visa.

Please complete the following three sections and then return the application pack and all supporting documents to The Travel Visa Company Ltd.

- 1. Checklist of the documents required

PLEASE NOTE

The Australia Subclass 600 permits stays of up to 3 months, 6 months or 12 months.

A Subclass 600 visa may be required for a number of reasons, including:

- Length of stay exceeds 3 months.
- Applicant has a criminal conviction which means they are not eligible for the eVisitor Visa.
- Applicant holds a passport from a country that is not eligible for the eVisitor Visa.

All applicants over 75 years of age will be required to undergo a medical examination at an authorised clinic. An additional fee will be charged to the applicant by the clinic on the day of the examination.

Please be aware that depending on the applicant's individual circumstances, additional documentation beyond that which is listed below may be requested.

If you are an Australian dual citizen, you must travel to Australia on an Australian passport. Even if you no longer hold a valid Australian passport, you will still be classed as an Australian citizen and will be required to renew your Australian passport in order to travel to Australia.

	COPY OF PASSPORT – Please include a copy of the photograph page of your passport. Your passport must be valid for at least the entire duration of your proposed stay in Australia.
	PROOF OF FUNDS - IF you are applying for a 12 month visa you must provide a copy of your most recent back statement. The statement must show you name, address and enough available funds to support yourself whilst in Australia.
	PROOF OF NAME CHANGE – IF you have ever changed your name, including through marriage, you MUST provide proof of name change. In the case of marriage, this would be a copy of your marriage certificate.
	POLICE CERTIFICATE (ACRO) – IF you have ever been convicted of any crime, in any country, you MUST provide a copy of an ACRO Police Certificate dated within the last 6 months.
