#### PLEASE NOTE

The Australia Subclass 600 permits stays of up to 3 months, 6 months or 12 months.

A Subclass 600 visa may be required for a number of reasons, including:

- Length of stay exceeds 3 months.
- Applicant has a criminal conviction which means they are not eligible for the eVisitor Visa.
- Applicant holds a passport from a country that is not eligible for the eVisitor Visa.

All applicants over 75 years of age will be required to undergo a medical examination at an authorised clinic. An additional fee will be charged to the applicant by the clinic on the day of the examination.

Please be aware that depending on the applicant's individual circumstances, additional documentation beyond that which is listed below may be requested.

If you are an Australian dual citizen, you must travel to Australia on an Australian passport. Even if you no longer hold a valid Australian passport, you will still be classed as an Australian citizen and will be required to renew your Australian passport in order to travel to Australia.

- ☐ **PROOF OF NAME CHANGE** – **IF** you have ever changed your name, including through marriage, you **MUST** provide proof of name change. In the case of marriage, this would be a copy of your marriage certificate.
- ☐ **POLICE CERTIFICATE (ACRO)** – **IF** you have ever been convicted of any crime, in any country, you **MUST** provide a copy of an ACRO Police Certificate dated within the last 6 months.
