Thank you for requesting an application pack for an Australia Tourist eVisitor Visa.

## **1** PLEASE NOTE

The Australia eVisitor Visa is valid for travel to Australia for tourist and business purposes. It is valid for 12 months and permits multiple entries of up to 3 months per entry.

If you are an Australian dual citizen, you must travel to Australia on an Australian passport. Even if you no longer hold a valid Australian passport, you will still be classed as an Australian citizen and will be required to renew your Australian passport in order to travel to Australia.

Those who have been convicted of a crime and the resultant sentence totalled 12 months or more will **not** be eligible for an eVisitor visa for Australia and are advised to contact The Travel Visa Company to discuss their options.
