Thank you for requesting an application pack for a Canada Tourist eTA.

Please complete the following three sections and then return the application pack and all supporting documents to The Travel Visa Company Ltd.

PLEASE NOTE

The Canadian eTA is valid for 5 years from the date of issue and permits multiple entries of up to 6 months.

An eTA is not required if you are entering Canada via land or sea, it is only required when entering via air.


If you have ever been arrested for, been charged with, or convicted of any criminal offence, you will be required to submit a Police Certificate (ACRO) and the processing time is likely to be **significantly** longer.

- CANADA ETA APPLICATION FORM** – Please find attached. It is important to carefully read through all the questions and fully complete all forms in **BLOCK CAPITALS** with a **BLACK PEN**. All application forms **MUST** be printed single-sided. Application forms printed double-sided **WILL NOT** be accepted.
- COPY OF PASSPORT** – Please include a copy of the photograph page of your passport. Your passport must be valid for at least the entire duration of your proposed stay in Canada.

- POLICE CERTIFICATE (ACRO)** – IF you have ever been convicted of any crime, in any country, you **MUST** provide a copy of an ACRO Police Certificate dated within the last 6 months.
- **DON'T HAVE AN ACRO?** – If you do not already have this document, The Travel Visa Company offer a service to obtain this on your behalf for an additional fee. Please visit www.thetravelvisacompany.co.uk/services/acro
