1 PLEASE NOTE

The Canadian eTA is valid for 5 years from the date of issue and permits multiple entries of up to 6 months.

An eTA is not required if you are entering Canada via land or sea, it is only required when entering via air.

If you have ever been arrested for, been charged with, or convicted of any criminal offence, you will be required to submit a Police Certificate (ACRO) and the processing time is likely to be **significantly** longer.

	COPY OF PASSPORT – Please include a copy of the photograph page of your passport. Your passport must be valid for at least the entire duration of your proposed stay in Canada.				
	POLICE CERTIFICATE (ACRO) – IF you have ever been convicted of any crime, in any country, you MUST provide a copy of an ACRO Police Certificate dated within the last 6 months.
