Thank you for requesting an application pack for a China Tourist Visa.

Please complete the following three sections and then return the application pack and all supporting documents to The Travel Visa Company Ltd.

PLEASE NOTE

Single entry visas are valid for 3 months from the date of issue and permit a single entry of up to 30 days into China.

Double entry visas are valid for 6 months from the date of issue and permit two entries of up to 30 days at a time.

Multiple entry visas are valid for 2 years and permit multiple entries of up to 90 days at a time into China.

If you are under the age of 70 and wish to apply for a multiple entry visa, please see our 'Pre-Check & Application Registration' service or contact us for further details.

If you are, or are travelling with someone, under the age of 18, please contact us before applying as you may be required to provide additional documents.

If you plan to visit Tibet during your stay, please contact us for further assistance.

What is included with our service?

- We quality check your application form and all supporting documents to ensure you have provided all the required information, reducing the risk of refusal.
- We complete the official online China Visa Application Form on your behalf.
- We submit your application and passport to the Chinese Visa Application Centre on your behalf and collect your passport once the visa has been issued.

CHINA VISA APPLICATION FORM – Please find attached. It is important to carefully read through all the questions and fully complete all forms in BLOCK CAPITALS with a BLACK PEN. All application forms MUST be printed single-sided. Application forms printed double-sided WILL NOT be accepted.
PASSPORT – Please include your original passport. Your passport must be valid for at least 6 months from your date of arrival in China and contain at least 2 blank pages.
 COPY OF PREVIOUS CHINA VISA – If you have previously held a visa for China, please include a copy of each page in your passport with a Chinese visa.
 PROOF RESIDENCE – If you are a non-UK national residing in the UK, you must provide your UK immigration share code on the application form. This can be obtained at: www.gov.uk/view-prove-immigration-status
PHOTOGRAPH x1 – The photograph must be standard passport size, taken within the last 6 months, against a light background, printed on photographic paper, be full face and non-smiling [without sunglasses, a hat/cap or other head covering, unless the applicant wears such items because of their religious belief or ethnic background].
TRAVEL ITINERARY – A copy of your hotel and flight booking confirmations or cruise itinerary. All itineraries MUST include ALL travellers' names; hotel names and addresses for your entire stay in China with check in and check out dates and ALL flight confirmations.
 INVITATION LETTER – If visiting family or friends in China, a letter of invitation is required including a copy of their Chinese ID Card or passport photograph page with a valid visa for China.
 PROOF OF RELATION – If visiting family, please also provide proof of the relation i.e. copy of marriage or birth certificate.
SELF DECLARATION LETTER – If you currently or have previously served in the military you are required to provide a self-declaration letter. The letter should state that you only wish to travel to China for tourism purposes and not for military purposes. This will need to be dated, signed and addressed directly to the Chinese Embassy. Contact us for further information.
SIGNED LETTER OF AUTHORISATION – Please find attached. It is important that this is completed, signed and dated. This is not required if you are over 70 and applying for a multiple entry visa.
Failure to provide us with these documents will result in delays with your application.
