An Equatorial Guinea E-Visa is valid for 90 days from the date of issue and permits a stay of up to either 30 or 90 days depending on the visa type requested.

	EQUATORIAL GUINEA E-VISA APPLICATION FORM – Please find attached. It is important to carefully read through all the questions and fully complete all forms in BLOCK CAPITALS with a BLACK PEN . All application forms MUST be printed single-sided. Application forms printed double-sided WILL NOT be accepted.
	COPY OF PASSPORT – Please include a copy of the first two pages of your passport, this is the bio-information page and the page that comes before it. Your passport must be valid for at least 6 months from arrival into Equatorial Guinea and must have at least 3 blank visa pages.
	PHOTOGRAPH x1 – The photograph must be standard passport size, taken within the last 6 months, against a light background, printed on photographic paper, be full face and non-smiling [without sunglasses, a hat/cap or other head covering, unless the applicant wears such items because of their religious belief or ethnic background].
	FLIGHT BOOKING – Please provide a copy of your flight ticket confirmation. All flight booking documents must show applicant's names, and entry into/exit from Equatorial Guinea.
	ACCOMMODATION CONFIRMATION – Please include a copy of the hotel booking confirmation detailing the address and check-in/out dates, or proof of your host's address in Equatorial Guinea.





	LETTER OF INVITATION – You must provide a business invitation letter issued by your inviting company in Equatorial Guinea. The invitation letter must include the applicant's name and passport number, full address of the company in Equatorial Guinea, purpose of travel and travel dates.
	YELLOW FEVER CERTIFICATE - Please include a copy of your up-to-date yellow fever vaccination certificate.
	TRAVEL INSURANCE - Please include a copy of your travel insurance document. This must clearly show the period of cover.
