Ghana Business e-Visa Application Pack

Thank you for requesting an application pack for a Ghana Business e-Visa.

Please complete the following three sections and then return the application pack and all supporting documents to The Travel Visa Company Ltd.

PLEASE NOTE

A Ghana Business e-Visa is valid 90 days from the date of issuance and permits a single entry of up to 30 days.

All travellers older than 9 months must be vaccinated against Yellow Fever. If you do not have an up-to-date vaccination, you will be required to receive the Yellow Fever vaccine upon arrival in Ghana.

- ☐ **GHANA BUSINESS E-VISA APPLICATION FORM** – Please find attached. It is important to carefully read through all the questions and fully complete all forms in **BLOCK CAPITALS** with a **BLACK PEN**. All application forms **MUST** be printed single-sided. Application forms printed double-sided **WILL NOT** be accepted.
- ☐ **PASSPORT** – Please include your original passport. Your passport must be valid for at least 6 months from your date of entry into Ghana.
- ☐ **PHOTOGRAPH** – The photograph must passport size, taken within the last 6 months, against a light background, printed on photographic paper, be full face and non-smiling [without sunglasses, a hat/cap or other head covering, unless the applicant wears such items because of their religious belief or ethnic background].
- ☐ **FLIGHT TICKET/TRAVEL ITINERARY** - Please include a copy of your flight ticket/travel itinerary which shows the applicants name and entry/exit flights.
- ☐ **ACCOMMODATION CONFIRMATION** - Please include a copy of your hotel booking confirmation. This document must show the applicant's name, hotel name/address and check-in/out dates.

- ☐ **YELLOW FEVER CERTIFICATE** – Please include your original, up-to-date yellow fever certificate.
- ☐ **BUSINESS INVITATION LETTER** – Please provide a letter of invitation issued by the inviting company in Ghana. This must be on company letter headed paper, include the applicant's name and passport number, detail the purpose of travel and the dates of travel. It must also include a statement accepting financial responsibility for the invitee whilst in Ghana and confirm that the invitee will comply fully with the immigration laws of Ghana. Letter must be addressed to the Ghanaian Embassy in London and signed by a relevant individual at the inviting company.
- ☐ **UK IMMIGRATION SHARE CODE** – If you are a non-UK national residing in the UK, you must provide your UK immigration share code on the application form. This can be obtained at: www.gov.uk/view-prove-immigration-status
