	PHOTOGRAPH x1 – The photograph must be visa size, 50x50mm (NOT STANDARD PASSPORT SIZE), taken within the last 6 months, against a light background, printed on photographic paper, be full face and non-smiling [without sunglasses, a hat/cap or other head covering, unless the applicant wears such items because of their religious belief or ethnic background].
	BUSINESS CARD – Please include a copy of both sides of your company business card.
	INVITATION LETTER – Please include a business invitation letter from the inviting firm in India address to 'High Commission of India'. The letter must be on the company's headed paper and be signed by an authorised signatory of the company, proxy signature will not be accepted. The letter must contain the purpose of visit, applicants name, passport number, issue date and expiry date, and the total duration of stay in India per entry.
