The Nigerian Immigration Department do withhold the right to request additional supporting documentation should they wish.


Please do not submit your application any later than 30 days prior to travel. Applications submitted within 30 days of your travel date risk rejection.

	NIGERIA E-VISA APPLICATION FORM – Please find attached. It is important to carefully read through all the questions and fully complete all forms in BLOCK CAPITALS with a BLACK PEN . All application forms MUST be printed single-sided. Application forms printed double-sided WILL NOT be accepted.
	COPY OF PASSPORT – Please include a copy of the photograph page of your passport. Your passport must be valid for at least 6 months from arrival into Nigeria and must have at least 2 blank visa pages.
	PHOTOGRAPH x1 – The photograph must be standard passport size, taken within the last 6 months, against a light background, printed on photographic paper, be full face and non-smiling [without sunglasses, a hat/cap or other head covering, unless the applicant wears such items because of their religious belief or ethnic background].
	FLIGHT CONFIRMATION – Please include a copy of the flight booking confirmation/ticket, it must show applicant's name and detail flights into and out of Nigeria.
