Sri Lanka Business eVisa Application Pack

Thank you for requesting an application pack for a Sri Lanka Business eVisa.

Please complete the following three sections and then return the application pack and all supporting documents to The Travel Visa Company Ltd.

PLEASE NOTE

A Sri Lanka Business eVisa is valid for 6 months from the date of issue and permits two entries of up to 60 days per entry.

All nationals are eligible for a 2 day transit eVisa waiver.

Nationals of certain countries are not eligible for an eVisa and must apply for a visa through the Sri Lankan Embassy. Additionally, some nationals, depending on their length of stay, are exempt from eVisa and visa requirements. To check your eligibility, please contact The Travel Visa Company.

British passport holders will require an eVisa, unless they are eligible for the 2 day transit eVisa waiver.

	COPY OF PASSPORT – Please include a copy of the photograph/information page of your passport. Your passport must be valid for at least 6 months from your date of entry into Sri Lanka.





	PHOTOGRAPH - The photograph must passport size, taken within the last 6 months, against a light background, printed on photographic paper, be full face and non-smiling [without sunglasses, a hat/cap or other head covering, unless the applicant wears such items because of their religious belief or ethnic background].
	BUSINESS INVITATION LETTER – Letter of invitation issued by your inviting company in Sri Lanka. Business invitation letter should detail your purpose of travel and intended travel dates.
