Sri Lanka Tourist eVisa Application Pack

Thank you for requesting an application pack for a Sri Lanka Tourist eVisa.

Please complete the following three sections and then return the application pack and all supporting documents to The Travel Visa Company Ltd.

PLEASE NOTE

A Sri Lanka Tourist eVisa is valid for 6 months from the date of issue and permits either a single entry of up to 30 days or two entries of up to 60 days per entry.

Sri Lanka do offer a Transit eVisa which permits stays of up to 4 days and can be used when entering Sri Lanka via cruise ship. For further information, please see our 'Sri Lanka Transit eVisa' service or contact us for further details.

All nationals are eligible for a 2 day transit eVisa waiver.

Nationals of certain countries are not eligible for an eVisa and must apply for a visa through the Sri Lankan Embassy. Additionally, some nationals, depending on their length of stay, are exempt from eVisa and visa requirements. To check your eligibility, please contact The Travel Visa Company.

British passport holders will require an eVisa, unless they are eligible for the 2 day transit eVisa waiver.
