PLEASE NOTE

To be eligible for this visa you must be aged 50 or above and in receipt of a state pension.


A Non-Immigrant Visa (O) is valid for 3 months from the date of issue and permits a single entry of up 90 days in Thailand.

Application forms printed double-sided **WILL NOT** be accepted.
- COPY OF PASSPORT** – Please include a copy of the photograph/information page of your passport. Your passport must be valid for at least 6 months from your date of entry into Thailand.
 - **PROOF OF RESIDENCE** – If you are a non-UK national residing in the UK, you must provide your UK immigration share code on the application form. This can be obtained at: www.gov.uk/view-prove-immigration-status
- PHOTOGRAPH** - The photograph must passport size, taken within the last 6 months, against a light background, printed on photographic paper, be full face and non-smiling [without sunglasses, a hat/cap or other head covering, unless the applicant wears such items because of their religious belief or ethnic background].

- PROOF OF ADDRESS** – Please provide either a recent utility bill dated in the last 3 months or UK driving licence showing your address.
- PROOF OF FUNDS** – Please provide evidence showing monthly income of no less than 65,000 THB (approx. £1500) or having the current balance of 800,000 THB (approx. £17,500), e.g. bank statements for the last 3 months, proof of earnings.
