A Single Entry Zimbabwe Tourist eVisa is valid for 90 days from the date of issue and permits the holder to stay in Zimbabwe for up to 30 days.

A Double Entry Zimbabwe Tourist eVisa is valid for 90 days from the date of issue and permits the holder two entries into Zimbabwe for up to 30 days at a time.

A multiple entry eVisa can be requested but does incur an additional fee. If you require a multiple entry visa, please contact us to discuss
