What is an Outbound Passenger Locator Form?

The purpose of a passenger locator or travel health form is to aid a country's ability to successfully track and trace individuals who may test positive whilst in a certain destination. If completing these forms yourself, often they must be completed within 24 - 72 hrs before entering a destination. By arranging these forms now, The Travel Visa Company will complete the administration on your behalf and forward the relevant confirmations to you at the appropriate time.

What is a UK Passenger Locator Form (PLF)

A UK Passenger Locator Form (PLF) is required when entering or returning to the UK from any other country in order to comply with track and trace requirements. If you do not complete your UK PLF prior to arrival, it may slow down your entry to the UK.

You can **complete your UK PLF before you travel** with The Travel Visa Company who will securely email you the confirmation within the 48 hours before your entry into the UK.

For those that will return to the UK on a cruise, lasting no more than 21 days, The Travel Visa Company can complete your UK PLF within the 48 hours before you set sail. You will be able to indicate this to us whilst completing your application.

When to expect your travel test(s)?

Your tests will be ordered with our UK Government approved provider, and dispatched within 3 -5 working days of receiving your application.

What happens when I submit this application form?

You can submit this application form either via email or by post.

Once received, we will send you email confirmation with a unique TVC reference number, along with further details in relation to the services you have opted for.

When completing this application, you **MUST** provide an email address that we can forward your passenger locator form(s) and test result(s) to.
