#### PLEASE NOTE

The Canadian ETA is valid for 5 years from the date of issue and permits multiple entries of up to 6 months.

An ETA is not required if you are entering Canada via land or sea, it is only required when entering via air.

If you have ever been arrested for, been charged with, or convicted of any criminal offence, you will be required to submit an ACRO Police Certificate and the processing time is likely to be **significantly** longer.
